#### **Suggested Attire**



# LEXINGTON & CONCORD TOUR

Saturday, July 20, 2024 • 10:00 am - 3:30pm Cost: \$197

On the evening of April 18, the famous ride by Paul Revere, William Dawes and others warned locals with shouts of "the British are coming!" Hear about the Battle of Lexington Green, and then follow Battle Road to Concord Bridge where "the shot heard around the world" was fired. The Liberty Ride is a 90-minute guided bus tour with opportunities to disembark. An entertaining and knowledgeable guide in authentic period dress will provide you with historically accurate information about the Battle of Lexington and Concord as well as life in Colonial America. During the ride you will see historic sites and attractions in both Lexington and Concord. Afterwards, the group will stop at Concord Colonial Inn for a buffet lunch.



**Bewitching Salem Tour** Sunday, July 21, 2024 • 11:45am - 6:00pm Cost: \$243

It may be most widely known as the site of the Salem witchcraft trials of 1692, but this colorful, coastal city has much to offer between its rich maritime heritage, historic architecture and amazing stories that span almost four centuries. You'll start the afternoon with lunch at the Derby restaurant where you'll hear a talk by an educator from the Salem Witch Museum while enjoying a family style lunch. During this program, participants will hear about the legal mistakes made during the year 1692 and how they led to the largest and deadliest witchcraft trial in North American history.

After lunch, you'll move on to the famous Salem Witch Museum! Walk the original, quaint brick pathways throughout downtown, and explore shops and attractions to enjoy. End the day with a visit to the House of Seven Gables.

Tour will be conducted rain or shine. Plan to wear comfortable walking shoes.

#### ISABELLA STEWART GARDNER MUSEUM TOUR

Monday, July 22, 2024 • 11:00am - 1:00pm Cost: \$132

Over three decades, Isabella Stewart Gardner traveled the world and worked with important art patrons and advisors to amass a remarkable collection of master and decorative arts. Mrs. Gardner installed her collection of works in a way to evoke intimate responses to the art, mixing paintings, furniture, textiles and objects from different cultures and periods among well-known European paintings and sculpture. The Gardner Museum has remained essentially unchanged since its founder's death in 1924. You'll experience an exclusive guided tour of the museum's three floors of galleries and the garden courtyard blooming with life in every season.

Watch the Netflix documentary series "<u>This</u> <u>is a Robbery</u>" about the 1990 theft of 13 works of art from the Isabella Stewart Gardner Museum's collection, a crime which remains unsolved to this day.
