## Legislative Update

The state legislatures are winding down (some have already adjourned for the year), and we're showing 182 introductions and 47 enactments of uniform and model acts, on pace for a very good year. Arkansas currently leads all states with 8 enactments. Idaho is not far behind with six enactments, and New Mexico ended its session with 5 enactments. The most successful act in the legislatures this year? That would be the Revised Uniform Anatomical Gift Act, which has already posted 9 enactments to date, with more expected before the end of the year. Revised UCC Articles 1 and 7 have each posted 4 new enactments this year, as have both the Uniform Prudent Management of Institutional Funds Act and the Uniform Child Abduction Prevention Act.

## UEVHPA Update

While the drafting committee on the Uniform Emergency Volunteer Health Practitioners Act continues its work, the act has been adopted in its first state: Kentucky. The Lexington Herald-Leader published a positive article on Kentucky's enactment: [click here](#) to read the article.
