## Legislative Update

We're a little more than half way through the legislative year, and we currently have 59 enactments and 239 introductions. Massachusetts and New Mexico lead all states with nine enactments each. While no other state may top those enactment totals, a number of other states are shaping up to have very good years: Oklahoma has three enactments with a realistic shot at 6 or 7 more, and Washington is close to completing five acts this year.
