Legislative Update

The 2008 legislative year is underway, and to date we have more than 160 introductions and 5 enactments. The District of Columbia has 3 out of the 5 current enactments. Oklahoma leads all jurisdictions with 11 introductions, while Michigan has 8 introductions. The Uniform Prudent Management of Institutional Funds Act has been introduced in 18 states, with more introductions expected. UPMIFA has been enacted in one new state this year, bringing its enactment total to 14. The Uniform Anatomical Gift Act has been introduced in 17 states and enacted in one more, bringing its total number of enactments to 20.
