## Legislative Update

The 2009 legislative year is now underway, and it's shaping up to be a very busy year. Although it's still very early, we have already recorded 15 new enactments, including two recent enactments in Ohio (the Uniform Anatomical Gift Act and the Uniform Prudent Management of Institutional Funds Act). The best news of the year so far: Massachusetts has just enacted the Uniform Probate Code, after many, many years of hard work. Massachusetts Governor Deval Patrick signed the UPC into law on January 15.

## New Members

Kansas has two new commissioners. Thomas Owens is a state senator from Overland Park, and replaces John Vratil. Sen. Owens is chair of the Senate Judiciary Committee. Lance Kinzer is a state representative from Olathe, and replaces Michael O'Neal. Rep. Kinzer is the chair of the House Judiciary Committee.

Our newest commissioner in Missouri is Lowell Pearson. Mr. Pearson is General Counsel in the Office of the Governor in Jefferson City.

In South Dakota, Thomas J. Deadrick is a state representative from Platte, replacing Sean O'Brien.
