Legislative Update

As we near the end of the legislative year, we currently show 206 introductions and 79 enactments of uniform and model acts, on pace for a very good year. Nevada is in first place, enacting 12 uniform acts this year. The Uniform Anatomical Gift Act continues as the most successful act in the legislatures, with 14 enactments and more expected soon.

New Members

In Oklahoma, there are three new members. Loyd Benson has been appointed a commissioner, replacing David Pomeroy. Mr. Benson, a former commissioner, is an attorney in Frederick, Oklahoma, and is a former Speaker of the Oklahoma House of Representatives. Fred Morgan is our newest associate member, replacing Cheryl Purvis. Mr. Morgan is an attorney with the Oklahoma State Senate in Oklahoma City. Glenn Coffee has been appointed a commissioner, replacing R. Stratton Taylor, who remains with the Conference as a Life Member. Mr. Coffee is an attorney and state senator from Oklahoma City, and is currently the Senate Co-President Pro Tempore.

In New York, our newest associate member is Jason Cooper, who replaces Jamie Lynn-Elacqua. Mr. Cooper is with the New York State Legislative Services Office in Albany.

In Puerto Rico, our newest associate member is Francisco Domenech, who is Director of the Puerto Rico Office of Legislative Services in San Juan.

In South Dakota, our newest commissioner is David Lust. Mr. Lust is a state representative from Rapid City, and replaces Gene Lebrun, who remains with the Conference as a life member.
