## Legislative Update

The 2009 legislative year is well underway. To date there are 211 introductions and 21 enactments. Massachusetts continues to lead all states with nine enactments. The Uniform Prudent Management of Institutional Funds Act leads all acts with 19 introductions and four enactments.

## New Members

Michigan has two new commissioners: Justin Amish is a state representative from Western Michigan and Andy Coulouris is a state representative from Saginaw.

In Colorado, our newest commissioner is Morgan Carroll, a state senator from Aurora, who replaces Ken Gordon as commissioner.

In California, state Senator Ellen Corbett from San Leandro is our newest member. Sen. Corbett is Chair of the Senate Judiciary Committee, and replaces Rep. Dick Ackerman as commissioner.

In Mississippi, state Senator Joey Fillingane from Sumrall has been appointed commissioner. Sen. Fillingane is Chair of the Senate Judiciary Committee, Division A.

In Puerto Rico, Eduardo Arosemena-Munoz has been appointed commissioner. Mr. Arosemena is Assistant Secretary of State for Services for Puerto Rico in San Juan.
