## Legislative Update

It's now official: we've closed the books on the 2008 Legislative Year. We ended the year with 185 introductions and 87 enactments – one of our best years for “off year.” Oklahoma and Utah each finished the year with six enactments; Colorado was not far behind with five enactments. For the second straight year, the Uniform Anatomical Gift Act led all acts with 15 new enactments this year; the Uniform Prudent Management of Institutional Funds finished a strong second with 12 enactments.

At the conclusion of the ULC's 117<sup>th</sup> Annual Meeting in Big Sky, seven new acts or amendments to acts were approved: Amendments to the Uniform Interstate Family Support Act; Amendments to the Uniform Common Interest Ownership Act; Uniform Common Interest Owners Bill of Rights Act; Revised Uniform Unincorporated Nonprofit Association Act; Uniform Unsworn Foreign Declarations Act; Amendments to the Uniform Probate Code; and Amendments to the Uniform Principal and Income Act.
